The challenge.

Illustrate Digital is a digital agency specialising in WordPress development and user experience design. Since 2010, the agency based in Cardiff has dedicated itself to designing, developing and growing WordPress websites for customers in the UK and across Europe.

"We started as hybrid design and web agency, but eventually we dropped print design," said Scott Jones, Managing Director for Illustrate Digital. "Then, we became a WordPress specialist agency, so we now only work in WordPress. Our approach, and what we do with our customers is plan, develop, grow. We first work on strategy, UX design, and site organisation. Then, we move onto WordPress or WooCommerce development, integrations, or pure PHP if we need to. Google speed ratings impact SEO and AdWords performance. If a site is incredibly slow, this affects how it appears in search results and also client perception. SEO is important because inbound leads (including from SEO) cost 61% less than outbound leads (like

cold calling), according to [Search Engine Journal](#). In Enable Law’s case, this had the potential to negatively impact their business.

“We really weren’t sure where we could go,” he said. “We needed a place to host our site, but up until that point our experiences had been mostly negative.”
